### **NEW BUSINESS:**

# JOE McDADE-B.I.A.-FIRE MANAGEMENT PLAN:

Joe confirmed that he is not here to talk about the fire management plan. Richard Poweski does the fire management plan and Joe said he would appreciate it if Te-Moak would pass Richard's resolution. There was a problem during the spring time because people would be wanting to burn willows, etc. If there are members are burning willows on the reservation and if it would be getting out of hand then the tribe would be liable if there wasn't a fire plan in place. Lindsey makes a motion to adopt resolution #26 (Wildland Management Plan for the Bureau of Indian Affairs Eastern Nevada Agency) with the correction of the format. Second by Richard Smith.

#### Vote 4-0-0

2012 Chimney Fire Burned Area Emergency Response. Joe says BIA is proposing that they must be restricted to livestock for at least two growing seasons to allow for prescribed seeded species to fully establish. Bryan states that this issue should have comment period. Joe said that BIA did take this issue to South Fork Band Council and they supported it. Davis makes the motion to adopt the resolution #27. Lindsey seconds.

Draft Resolution Approving the Battle Mountain Band Liquor License for Smoke Shop was presented to Te-Moak Council. Paula Brady makes the motion to adopt resolution #29. Richard Smith seconds.

### **SOUTH FORK LAWSUIT:**

Bryan reads a letter from BIA regarding the Court Magistrates. Davis states when he was Te-Moak Chairman there were just two judges. Lois Whitney stated that when Bryan went out to South Fork caused chaos and escaladed to an arrest of a tribal member. Vince's wife talked to the Tribal cop in South Fork and said there was a decision made. Vince said this case was a sovergn immunity case. Vince said the judge should be banned from the court systems. Bernice said that the resolution passed by Te-Moak made Paula and Bryan being check signers but South Fork Band are still signing checks. Bernice stated the resolution has never been rescinded. Davis suggested to go ahead and select a election committee and let South Fork run their elections. Lois said some of the members out in South Fork was holding an illegal council meeting that resulted in an incident with a tribal member. Lois said they are asking the council the stand up for their people and get a hold of what they are suppose to do for the safety of their people.

Davis make a motion to select the election committee for the South Fork Election and have Art

Lindsey makes a motion to have Te-Moak Council take over for the South Fork Band Council. The South Fork Band has been recalled and Te-Moak will take over until new council comes in. So day to day operations will continue until elections are done. Richard Smith second.

Vote: 3-1-0 (Davis is against)

Bryan wants to include the whole Te-Moak Council to be check signers for the South Fork Band. Amend TM-09 to include Richard Smith and Lindsey Oppenhein. Lindsey makes a motion to amend Resolution #30. Second by Paula Brady.

Vote: 3-1-0 (Davis abstained)

Lindsey makes a motion to have Art swear in whoever needs to be sworn in to get an election committee. Davis seconds.

Vote: 4-0-0

Lindsey adds: Te-Moak gives the authority fo r Art Thompsomn swear in whoever needs to swear in to get this election going.

Leta said the the officers are not allowed to go out to the reservation. Find out where we are at on the finances or do an audit.

Paula motions to dismiss the case from Zeh. Lindsey seconds.

Vote: 4-0-0

# **VINCE GARCIA-SOUTH FORK LAND ASSIGNMENTS:**

Bryan wants to wait to find out while we dismiss the case.

# **MYRON TYBO-GRAZING ORDINANCE:**

The magistrate is not recognizing the Te-Moak Tribe and South Fork Band Members rights are being violated.

### **CHAIRMAN UPDATE-SEX OFFENDER CONCERNS (JESSE ANDERSON):**

Bryan received a letter regarding Jesse Anderson (new hire for ITCN) and some how got passed a background check. Chairman Burk and Moil notified Bryan that Jesse Anderson has been fired and legal action is being taken.
