#### **ROLL CALL:**

Chairman Davis Gonzales called the meeting to order at 6:03 P.M. with eight (8) members present with seven voting constituting a quorum.

The agenda was reviewed and approved with no changes. Michelle moved to approve, 2<sup>nd</sup> by Alice

#### REPORTS

Tribal Chairman: Chairman Gonzales gave his report.

**CEO Cathy Welchert** was given the floor. She introduced herself and Dr. Hastings the new Dentist. She gave the quarterly report for the clinic. Dr. Hastings discussed in length the Dental Program and the needs of improvement for a better dental clinic.

**Tribal Administration:** Phaline Conklin gave her report. There is discussion amongst the audience and council about Enrollment.

**Finance Report** Finance Office is ill. The sequester was discussed. The finance report was read by the Administrator. A suggestion was made to have a Finance conference call with Bands Finance to discuss ASAP. Correct the General Fund typo.

The floor was then given to Fish and Wildlife Wendy Fuell. A joint project with the Forest Service, BLM and Tribe. She gave a description of the Ft. Ruby Interpretive Trail Project. Those present with Wendy were Grace Newell and Fred and Lueanne, Archeologist. A trail is being proposed. FY2014 money is available and September 2014 it must be completed. The trail is a 2 mile loop with at least 2 to 3 panels that describes the history and the fort that tells the story. Evelyn Roche-Temoke will take the lead on this project with Alice Tybo. The Cultural center was discussed regarding the Cultural Advisory Committee. It was suggested that this be incorporated together.

### **OLD BUSINESS**
