ROLL CALL:

Chairman Davis Gonzales called the meeting to order at 6:05 P.M. with six (6) members present with five (5) voting constituting a quorum.

REPORTS

IHS-Cathy Welchert CEO

Cathy Welchert CEO is present to give her report of the council. The clinic is going through a quarterly review this evening so Cathy will give her report first. She talks of the psychologist coming on board on May 19th, 2014.. As also a Telephonic Child Psychologist available.

The Preferred Referred Care (PRC) formerly known as Contract Health Service. The expenditures at this time are approximately \$30,000 per week.

Revenue collections have increased by doubling the prior year. Currently the Business Office Manager is reporting at 54% collection for this year as revenue. Possible collection for past years of \$250,000 for 2 years is in the process from Nevada Medicaid.

Survey for AAAHC is June 3rd and 4th, 2014. Also the clinic is having a survey for reaccreditation for a Medical Home for the clinic

SUMT meetings are being held monthly. This month it will be held in Duckwater, May 15th.

The ADHOC committee meeting is held at the same date.

An assessment will be done for IT and for dental for improvements.

Chronic Pain medication discussion and procedures. It was indicated that CDL physicals will not be provided due to a liability. It was asked by the Tribal Administrator for a letter to be provided regarding this change.

Chairman Reports

Chairman Gonzales gives a report of his monthly activities. He discusses the Schurz Service Unit and the closure of the service unit.

Gaming Compact has been received and is being followed by Mark Oppenhein and in the process of the Compact with the State.

Western Cultural Advisory Committee is discussing a Museum for the Shoshone People to be located approximately near the Trails Center.

He discuss the Land Bills and what is going to be able to do with the lands.

There is a lengthy discussion regarding the process and legalities of the Lands. This discussion has been ongoing regarding the permits. South Fork has the responsible to issue the Grazing Permits. Te-Moak Tribe must approve the fees because there is no Grazing ordinance. The question to the council has given the approval to BIA to issue permits. There is a discussion regarding the purchasing of the lands. There is no Grazing ordinance. Vince is asking for the Te-Moak Tribe to support him and tell South Fork to 'butt out' because they have the water.

There is discussion of the fracking and the effects on community and water. There are many areas that are in discussion with the BLM from many companies, Nobel Energy to be the main one.

Rich Adams also discusses his play within the lands for Guzzlers and Catch Basins for wildlife and horses.

Rich Adkins discusses the Tosawii Quarry and his part on how he deals with the Bands and or Tribe. Rich is waiting for the MOU for the Quarries. They have had no response from the last meeting with the collaboration of the different community representatives.
